## ELECTRIC SERVICE FRANCHISE ORDINANCE

AN ORDINANCE granting unto Wolverine Power Supply Cooperative, Inc., its successors and assigns, the right, power and franchise for a period of thirty (30) years from and after adoption and approval hereof, to acquire, operate and maintain in Odessa \_\_\_\_ Township, \_\_ the necessary facilities for the production, transmission, and sale of electric energy at wholesale to its member-distribution cooperatives and between Wolverine other parties pursuant to wholesale power agreements, and to use and occupy the highways, streets, alleys, and other public places of the township to set poles, string wires, lay pipes or conduits, and to transact an electric business.

## BE IT ORDAINED:

Section 1. That Wolverine Power Supply Cooperative, Inc., its successors and assigns, be and it is hereby granted and vested with the right, power, and franchise for a period of thirty (30) years from and after the adoption and approval hereof, as provided by law, to acquire, construct, maintain or operate in the Township of \_\_\_Odessa \_\_\_\_ the necessary facilities for the production, transmission, and electric energy at wholesale to its member-distribution cooperatives and between Wolverine and other parties pursuant to wholesale power agreements, and to construct and maintain along, upon, across or under the highways, streets, alleys, and other public places of the township to set poles, string wires, lay pipes or conduit and other necessary fixtures and equipment for such purposes within \_\_\_\_Odessa \_\_\_\_ Township.

Section 2. The Grantee shall save the Township harmless from any liability or judgment that may be made or recovered against the Township by reason of the negligence of the Grantee in the construction or maintenance of its electric transmission system.

Section 3. The franchise granted herein is subject to confirmation at the next regular election or special election by a majority of the \_\_\_\_\_Odessa\_\_\_ Township electors voting upon the question in the affirmative.

Section 4. This ordinance will take effect upon publication of the ordinance.
